By-law No. 2025 - 05

Being a By-law to appoint a Municipal Law Enforcement Officer; and also a Tobacco Enforcement Officer, Weed Inspector and Zoning By-law Enforcement Officer.

WHEREAS section 8 of the *Municipal Act*, 2001, S.O. 2001, c. 25, as amended, provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the Act; and

WHEREAS Section 11 of the *Municipal Act*, 2001, provides that a lower-tier municipality may pass By-laws respecting matters within the spheres of jurisdiction set out therein, and is responsible for the enforcement of the By-laws pertaining to those sections; and

WHEREAS Section 227 of the *Municipal Act*, 2001, authorizes Councils to pass Bylaws for appointing such officers and employees as may be necessary for the purposes of the Corporation, for carrying into effect the provisions of any By-law of the Council; and

WHEREAS provisions contained in Section 1.1 of the *Provincial Offences Act*, R.S.O. 1990, c.P.33, include a Provincial Offences Officer as an officer, employee or agent of any municipality or of any local board of any municipality whose responsibilities include the enforcement of a By-law, an Act or a regulation under an Act, while in the discharge of his or her duties; and

WHEREAS provisions are included under the *Provincial Offences Act*, the *Weed Control Act*, the *Pounds Act*, the County of Simcoe and Township of Essa prohibitive smoking By-laws, and the Township of Essa Zoning By-law to provide for municipal enforcement; and

WHEREAS Section 15 of the *Police Services Act*, R.S.O. 1990 c. P.15, as amended, authorizes a Municipal Council to appoint persons who shall be peace officers for the purposes of enforcing municipal By-laws; and

WHEREAS Council of the Township of Essa deems it advisable to appoint a Municipal Law Enforcement Officer and any inspectors and administrators as are necessary for the purposes of the enforcement of said Acts and By-laws;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ESSA ENACTS AS FOLLOWS:

1. That Nathan Degagne be and is hereby appointed to the position of Municipal Law Enforcement Officer in accordance with the *Police Services Act*, R.S.O. 1990, c. P. 15, as amended, for the Township of Essa to carry out the duties and responsibilities as set out in the job description for the period during which she is an employee of the municipality.

- 2. That Nathan Degagne be and is hereby appointed as a Tobacco Enforcement Officer, Weed Inspector, Canine Control and Zoning Enforcement Officer; and shall perform all the duties required to be performed by the said titles under statutory authority and other duties that may be imposed by the Council of The Township of Essa for the period during which she is an employee of the municipality.
- 3. That Nathan Degagne does hereby agree and acknowledge to abide by the Township of Essa's policies and procedures, including the Acceptable Computer Usage Policy, the Employee Code of Conduct, the Corporation's Health and Safety Program, and other policies as provided.
- 4. That the said appointment shall become effective as of January 13, 2025.
- 5. This By-law shall come into force and effect on the day it is finally passed.

BY-LAW NO. 2025 - 06

Being a By-law to appoint an additional Deputy Clerk and Director of Infrastructure for the Township of Essa.

WHEREAS Section 228 (1) of the *Municipal Act 2001*, S.O. 2001, c.25, states that a municipality shall appoint a Clerk whose duty it is,

- a) to record, without note or comment, all resolutions, decisions and other proceedings of the Council;
- b) if required by any member present at a vote, to record the name and vote of every member voting on any matter or question;
- c) to keep the originals or copies of all by-laws and of all minutes of the proceedings of the council;
- d) to perform the other duties required under this Act or under any other Act;
- e) to perform such other duties as are assigned by the municipality; and

WHEREAS Section 228 (2) of the *Municipal Act 2001*, S.O. 2001, c.25 states that a municipality may appoint deputy clerks who has all the powers and duties of the Clerk under this and any other Act; and

WHEREAS to ensure the business continuity of the Council of the Corporation of the Township of Essa deems it desirable and necessary to appoint the Chief Administrative Officer as an additional Deputy Clerk; and

WHEREAS the Council of the Township of Essa deems it desirable and necessary to appoint the Chief Administrative Officer as the Director of Infrastructure;

NOW THEREFORE BE IT RESOLVED THAT Council of the Corporation of the Township of Essa hereby enacts as follows:

A By-law to amend By- law 2005-23, that being a By-law to regulate the operation of Motorized Snow Vehicles in the Township of Essa, and to authorize execution of a Memorandum of Understanding with Bonsecour Track and Trail Snowmobile Club.

WHEREAS Section 7 of the Motorized Snow Vehicles Act provides that a Council of a local municipality may pass by-laws regulating and governing the operation of motorized snow vehicles within the municipality including highways therein or any part or parts thereof; and; and

WHEREAS it is deemed expedient to prohibit the use of motorized snow vehicles on sidewalks or boulevards and park areas within the settlement areas of The Township of Essa; and

NOW THEREFORE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF ESSA HEREBY ENACTS AS FOLLOWS:

- That Council authorize execution of a Memorandum of Understanding between the Township of Essa and the Bonsecour Track and Trail Snowmobile Club, specific to providing permission for use of prescribed snowmobile trail land in the Township of Essa.
- 2. That By-law 2005-23 be amended to include the amending provisions as contained in Schedule A to this By-law.
- 3. This By-law shall come into force and take effect on the final day of passing thereof.

- A. The Parties entered into a binding Memorandum of Understanding on December 9, 2011, for the purpose of granting snowmobile trail land use permissions on the Thornton-Cookstown Trans Canada Trail ("MOU").
- B. This Amending Agreement is being entered into for the purposes of adding a Schedule "A" to the MOU to specify and include certain roadways and crossings for motorized snow vehicles.

NOW THEREFORE THIS AGREEMENT WITNESSES that in consideration of the mutual covenants and agreements herein, the sufficiency of which is acknowledged, and subject to the terms and conditions set out in this Amending Agreement, the Parties agree as follows:

- 1. Capitalized terms in this Amending Agreement shall have the same meaning ascribed to them in the MOU unless the context otherwise requires.
- 2. Section 12 of the MOU is deleted and replaced with the following new Section 12: Additional Conditions: On the former abandoned rail line north of Cookstown at Essa Innisfil boundary to Thornton Essa Innisfil boundary at Innisfil Beach Road and County Road 27, and north of County Road 21 to County Road 90, north easterly to County Road 27 and north westerly to 6th Line Essa north of 30 Sideroad, including roadways and crossings. (See Schedule "A" for roadway and crossing maps).

- 3. The MOU is revised by adding a new Schedule "A", which is attached to this Amending Agreement as Schedule "A".
- 4. Except as set out in this Amending Agreement, the terms and conditions of the MOU remain in full force and effect.
- 5. This Amending Agreement may be executed in two or more counterparts, each of which together shall be deemed an original, but all of which together shall constitute one and the same instrument. 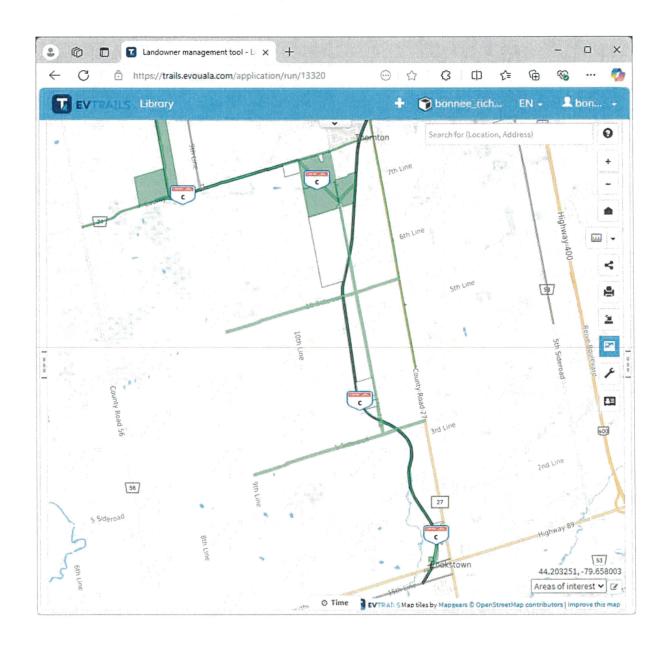

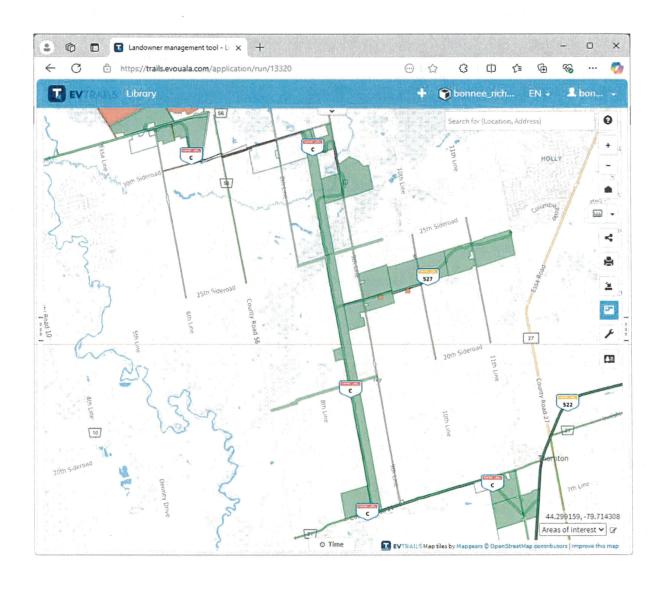
