We, the undersigned, recognize that Essa Township Council have only recently been made aware of this Official Plan and Rezoning Application. We understand that Essa Township Council does not have a position at this time in regards to the application.

We recognize the value placed by our Essa Township Council in retaining and protecting agricultural lands and maintaining community. As such, we appreciate that Council and Essa Township Planning Staff **defer consideration** of the Official Plan and Rezoning Application by T.C. Land Inc. for 8949 Smith Road and 5743 County Road 90 in Essa **AND** request the applicant and Township Staff report to a future public meeting on the following issues (which have yet been addressed in the required depth in the reports provided to-date):

- 1. TRAFFIC AND TRANSPORTATION: How will the safety of motorists/others be addressed at the Highway 90/Smith Road intersection, by R.J. Burnside's own admission of a "conservative analysis", of at least 149 left turns there at its A.M. peak hour at this unsignalized intersection on a very busy and fast Highway 90 that is seeing its volumes increasing day-to-day, given the growth of the uses served by this transportation corridor (Barrie Angus Wasaga Beach/Georgian Bay)? Where is the analysis of these future traffic flows?
- 2. ENVIRONMENT: Where are the NVCA's comments that should be received PRIOR to the Township making a decision, on the effect of the proposed development on (A) waterflows to the Minesing Wetlands (through the Arnum Creek onto the Nottawasaga River and otherwise); (B) water resources (eg. wells), especially on nearby properties; (C) the adequacy of the proposed "protection" of the Arnum Creek/wetlands; (D) the adequacy of the proposed two retaining ponds in all aspects; and (E) the effects on species-at-risk (especially the identified/present Eastern Wood Pe-Wee, Snapping Turtle, Hine's Emerald, Blanding's Turtle and the Midland Painted Turtle)?
- 3. **NEIGHBOURHOOD ISSUES**: Where is the Site Plan that will specify the details of issues such as: **(A)** the number/rows/species landscaping, especially trees, along Highway 90, Smith Road, and internal road system (to ensure a buffer effect, aesthetics, and adherence to provincial/federal directions to positively address climate

change effects through such plantings and water absorption measures, such as significant areas of soft landscaping/trees)?; (B) the location and direction of lighting to avoid unnecessary and bothersome light pollution such as the one that has been created at the Industrial Developments on both sides of Highway 56 just north of 30 Sideroad, by companies such as DeCast?; and (C) the exact location of parking spaces/sidewalks to ensure the safety of pedestrians and other users?
