RE: National Childcare Program

Please be advised the Council of The Corporation of The Town of Niagara-on-the Lake, at its regular meeting held on December 20, 2021, passed a motion in support of The City of St. Catharines resolution in regard to the National Childcare Program,

"WHEREAS the province of Ontario has the most expensive childcare in the country, presenting a financial hardship for many families and a barrier for women's full economic participation; and

WHEREAS the \$34 billion early learning and childcare spending commitment announced this year by the federal government will bring transformative change to childcare by lowering parent fees and expanding the supply of regulated not-for-profit and public childcare in this country; and

WHEREAS the federal government has already reached childcare agreements with BC, Nova Scotia, Manitoba, Saskatchewan, Yukon Territory, PEI, Newfoundland and Labrador and Quebec; and

WHEREAS the provisions of each agreement vary to some degree, but the majority of the jurisdictions have agreed to use the federal funds to:

- (a) lower parent fees by 50 per cent by the end of 2022 and to \$10 a day by 2025-26 or sooner;
- (b) improve the wages and working conditions of early childhood educators, and
- (c) publicly fund the expansion of not-profit and public childcare;

THEREFORE BE IT RESOLVED that the City of St. Catharines request that the provincial government take the necessary steps to work with the federal government on a bilateral agreement to ensure the new national child care program be made available to Ontarians, and that it focuses on increased access, affordability, quality and responsiveness, all of which are essential to the COVID-19 pandemic response; and

BE IT FURTHER RESOLVED that staff actively monitor federal developments and engage in provincial and regional discussions; and

BE IT FURTHER RESOLVED that City Council request the City Clerk circulate Council's decision to other municipalities in Ontario, the Ontario Municipal Social Services Association and the Association of Municipalities of Ontario."

AMO Policy Update – MOI Broadband Webinar, Joint + Several Liability Resolution and Federal Housing Accelerator

Broadband Webinar

On Thursday January 13, 2022, members of municipal council and CAOs received an **emailed invitation** from Jill Vienneau, Assistant Deputy Minister, Broadband Strategy Division to attend a webinar on broadband deployment in Ontario to meet the commitment to connect all homes and businesses to high-speed internet by 2025.

Municipal governments have played a critical role in supporting broadband expansion and will continue to do so as the projects approved under the Ontario Reverse Auction in spring 2022 require access to rights of way and public infrastructure. This webinar will provide an update from Minister Surma and a presentation from Ministry officials on the status of projects, planned actions and requirements.

AMO members are encouraged to attend the session which will be held on January 18^{th} , 2022, from 2:00 – 4:00 p.m.

Joint and Several Liability Resolution

Recently, AMO <u>wrote</u> to members regarding the status of commitments to review Joint and Several Liability and the need to encourage the Ontario Government to put a plan in place with municipalities to address this issue before the end of the current

mandate. Members were asked to consider passing a resolution to support the request and to send it to relevant Ministers and copy AMO.

AMO thanks those members that have already done so and has drafted a <u>standard</u> <u>resolution</u> for members that may still be interested in supporting this call. If you have not already done so, councils are encouraged to discuss the request at their next meeting and consider the attached draft resolution.

Federal Housing Accelerator

Municipalities and the public are invited to share their ideas on how the federal Housing Accelerator Fund and Rent-to-Own programs could be most effective. The Housing Accelerator Fund will aim to remove barriers and help municipalities build housing more quickly in an ambitious and innovative manner, while the Rent-to-Own program will aim to help make it easier for renters to work towards home ownership. Ontario-Municipal Summit Seeks Solutions to Build More Homes

Today, Ontario's Big City Mayors (OBCM), Mayors and Regional Chairs of Ontario (MARCO), and AMO President Jamie McGarvey met with Premier Doug Ford and Minister of Municipal Affairs and Housing, Minister Steve Clark, at the <u>Ontario</u> <u>Housing Affordability Summit</u>.


Premier Ford announced more than \$45 million for a new Streamline Development Approval Fund to help Ontario's 39 largest municipalities modernize, streamline, and accelerate processes for managing and approving housing applications. Over \$8 million was announced through the Audit and Accountability Fund to help large urban municipalities identify potential savings and efficiencies through third-party reviews to further accelerate the creation of new housing and modernize municipal services.

The provincial government has also committed to working with the municipal sector to develop a data standard for planning and development applications to help accelerate approval timelines. This work is part of the <u>Ontario Data Authority</u> initiative, designed to accelerate Ontario's economic and social growth through improved data sharing. AMO's Digital Government Task Force has been recently re-purposed to work on this needed data standard.

AMO agrees with the province that everyone has a role to play in addressing Ontario's housing crisis and reiterates that housing affordability is a shared responsibility requiring commitment and coordination from all orders of government and the non-profit, co-operative, and private sector. Today's Summit was a good start and there is more work to do. AMO looks forward to continuing to work with our partners to address Ontario's housing crisis, including at the upcoming Rural Housing Affordability Roundtable. The Premier and Minister will be hosting this Roundtable at the ROMA Conference on January 23rd with rural, remote, and northern municipal leaders.

AMO Policy Update – Pre-Budget Submission, New Joint & Several Technical Group, Phase 2 CA Regulations, and Provincial Gas Tax Boost

AMO Pre-Budget Submission

Today, Jamie McGarvey, AMO President, delivered the Association's Pre-Budget Submission to the Standing Committee on Finance and Economic Affairs. His remarks highlighted three key themes for the fiscal year that lies ahead:

- 1. AMO seeks a provincial budget that continues to address pandemic-related municipal costs with ongoing intergovernmental cooperation and investment.
- 2. A budget that does not impose new unfunded responsibilities upon municipalities and builds for the future; and
- 3. A budget that accounts for inflation in cost-share programs, Ontario Municipal Partnership Fund allocations, and provincial payments in lieu of taxes.

His address highlighted growing municipal capital contributions to new hospital construction and the need to re-think funding approaches. The full written submission is <u>linked here</u>. Municipalities are encouraged to re-enforce the above themes in their submissions to the government and note highlighted emerging trends.

Municipal Insurance Costs: Joint and Several Liability Technical Review

Attorney General Doug Downey has asked his Ministry to convene a Technical Working Group on joint and several liability. The Working Group is anticipated to begin work in March and will start by examining suggestions made by AMO. The announcement responds to recent calls by AMO and municipalities for the government to create a plan to address this long-standing challenge before the end of the Government's mandate.

Municipalities have experienced substantial increases in insurance costs and joint and several liability is one driver of insurance rates long identified by the municipal sector. Other drivers include climate change and the insurance market.

The Working Group will also include insurance industry representation and is a positive step by the Government. While AMO recognizes that a solution is unlikely before the June Ontario election, it is hoped that the discussions will lay the groundwork for action afterward.

Phase 2 Regulations of the Conservation Authorities Act Posted

Today, the Ministry of the Environment, Conservation and Parks posted the <u>second</u> <u>phase of regulations</u> under the *Conservation Authorities Act*. The posting proposes how the CA programs and services will be paid for, including the municipal levy, the voting mechanism, and other governance and transparency matters.

As part of this consultation, the Ministry is hosting three webinars in February, including one focused for municipalities and municipal associations on February 8th. AMO will provide comments on the submission which are due in 30 days (February 25, 2022).

Ontario Gas Tax Boost

On January 21, 2020, the Honourable Caroline Mulroney, Minister of Transportation <u>announced</u> that the province will provide an additional \$120.4M in one time funding to top the Ontario Gas Tax for Transit Program in 2021-22. This funding brings the program to \$375.6M for the year and stabilizes it after gas tax revenues decreased during the pandemic.

The Ontario Gas Tax for Transit Program provides two cents for every litre of gasoline sold in the province. The funds are allocated based on transit ridership and can be used to support transit capital and operations. The funds are provided to 107 municipalities and support transit services in 142 communities.

Gas Tax funding stability was recommended by AMO and will provide important supports to municipal transit as the pandemic continues to challenge ridership levels.

This funding is in addition to previously announced specialized COVID-19 transit supports by the provincial and federal governments.

Along with the recent <u>doubling</u> of Ontario Community Infrastructure Fund (OCIF), Ontario municipalities will be able to plan expenditures to improve important local services.

Simcoe County to participate in provincial Point-in-Time Homelessness Count

Midhurst/January 17, 2022 – In January 2022, Simcoe County will take part in a coordinated effort to measure homelessness across Ontario. The homelessness enumeration project is delivered locally in partnership between the Simcoe County Alliance to End Homelessness (SCATEH) and the County of Simcoe.

Over three days, service providers will count and survey individuals who are staying in shelters, short-term housing, temporary accommodations, and sleeping rough (without shelter). The Point-in-Time Homelessness Count (PiT Count) will provide a "snapshot" of homelessness in Simcoe County.

The survey will indicate the *minimum* number of people experiencing homelessness in our community. Other forms of homelessness, such as people staying temporarily with friends, are difficult to count in a PiT Count.

The PiT Count will improve the community's understanding of the needs and circumstances of the people who are affected by homelessness in the region. The survey will provide key data on gender, age, ethnicity, veteran status, and more.

Results from the PiT Count will be made publically available at <u>www.simcoe.ca/enumeration</u> and <u>www.scateh.com/enumeration</u>. The County of Simcoe and SCATEH will use the results of the PiT Count to improve local response to homelessness. In the future, successive counts will allow the County of Simcoe and SCATEH to measure progress towards the shared goal of ending homelessness in Simcoe County.

We are well on our way to reaching our goal of 2,685 new units between 2014-2024 under *Our Community 10-Year Affordable Housing and Homelessness Prevention Strategy*. Find your fit with a cart size that suits your household needs

Midhurst/January 17, 2022 – The County of Simcoe is pleased to introduce a new cart request program to support residents and businesses' capacity and storage needs. Starting January 17, 2022, business and homeowners can visit carts.simcoe.ca to swap their garbage and/or recycling cart for a smaller size. Exchanges will be free of charge until July 30, 2022.

"Our residents deserve a great deal of credit for adapting so well to the new automated cart collection system," said Warden George Cornell. "Myself, and many of our Councillors, have heard firsthand how so many residents have enjoyed the benefits and conveniences of this new program. While we had some learnings the first few weeks due to the scale of this significant change, we've quickly seen the improvements in alleviating labour challenges and ultimately reducing collection misses for our residents. For households that would prefer smaller carts, the County is now pleased to offer a simple and easy way for residents to swap their existing carts for different sizes."

Cart Sizes Options:

Residents are now able to choose the cart size that fits their needs. Cart sizes available for selection are:

- Recycling 360 L (default size), 240 L, 120 L
- Garbage 240 L (default size), 120 L
- Organics 120 L only



Cart size dimensions include:

How to Submit Your Request

To submit your cart exchange request, residents and business owners can visit <u>carts.simcoe.ca</u> and go to our 'Size Swap' section. This page provides all the relevant information about swapping your recycling and/or garbage cart, including a link to our online portal where you can make your request. For those people unable to access our website, requests can be made through our Contact Centre via phone at 1-800-263-3199. However, due to call volumes for all County Services, the most efficient and timely way to complete your cart swap request is through carts.simcoe.ca.

Prior to requesting a cart exchange, residents should consider the following information:

- Requests can only be made by home/property-owners. Renters should contact their landlords or property managers for assistance
- The first cart exchange/set of cart exchanges for each eligible County household is free until July 30, 2022
- For any subsequent exchanges (maximum once annually) or exchange requests made after July 30, 2022, there is an administration fee of \$50 per cart, unless you are a new homeowner
- Exchange deliveries will commence in early March and may take several weeks to complete. You will be notified prior to delivery to have your current EMPTY cart(s) at roadside for the exchange to occur
- Please carefully select the best size for your household. If smaller carts are selected and the location has consistent overflow of materials or overstuffed carts, the location will be required to revert to a larger size cart and the \$50 per cart administration fee will be applied. Overflow garbage must have a \$3 tag affixed

One additional recycling and/or organic cart may be requested by contacting Service Simcoe. Some conditions and a \$50 per cart administration fee apply.

- Service Simcoe

Tourism Simcoe County Tourism Service Delivery to the Heart of Georgian Bay

The Economic Development Corporation of North Simcoe (EDCNS), comprised of the communities of Midland, Penetanguishene, Tay and Tiny, was formed in 2014 with four strategic objectives for economic development in North Simcoe: Agriculture, Advanced manufacturing, Healthcare and Tourism. *The Heart of Georgian Bay* (HGB) is a Destination Marketing Organization mandated by EDCNS to promote these municipalities and increase visitation to the area.

In 2021, the EDCNS analyzed the productivity and efficiencies of the HGB and the decision was made that it would be far more effective to have Tourism Simcoe County (TSC) deliver tourism services for the region, rather than the EDCNS. TSC is also known as Experience Simcoe County, and is a service group within Service Simcoe. TSC continues to serve a growing role of supporting tourism operators and partners, while increasing efforts to grow tourism visits with direct operator support, visitor marketing, experience and product development, and media relations.

On January 11, 2022, Council voted to enter into a Service Delivery Agreement to deliver on an outline and plan for Tourism Simcoe County to provide Tourism destination marketing and management services to the Heart of Georgian Bay.



Paramedic Services Power Lift Assist Procurement

The power lift assist device has become a standard safety item across the province with 87% of Ontario Paramedic Services using a powered lift assist system, many of whom have done so for many years. Research has shown lift assist devices minimize the opportunity for injury to staff. The device also protects patients from accidental stretcher drops and has been tested and proven to be more secure in the event of a motor vehicle collision involving the ambulance.

On January 11, 2022, Council approved accelerating procurement of all power lift assist devices in 2022 in anticipation of a price increase in the first quarter of 2022 and a second inflationary price increase in the first quarter of 2023. This opportunity to potentially avoid a market and inflation-based price increase through early procurement also results in quicker deployment of these safety devices.

Child Care and Early Years Workforce Funding

On September 28, 2021, the Ministry of Education advised Municipal Service Managers (MSM) that Canada and Ontario had signed a new Early Childhood Workforce Funding Agreement, providing approximately \$149.9 million in one-time funding to support the retention and recruitment of a high-quality child care and early years workforce across the province. The County of Simcoe has since received a notional allocation of one-time funding totalling \$2,789,670 for 2022, and \$697,417 for the first quarter of 2023. This funding is pending provincial confirmation, subject to approval of a brief Service Manager Planning Report, due to the Ministry of Education on December 17, 2021.

While the licensed child care sector has for many years now experienced staff recruitment and retention issues, this has been exacerbated by the

current pandemic. Simply put, operators are struggling to maintain the levels of staffing required to meet pandemic related health guidelines, most significantly enhanced staff to child ratios. As such, overall capacity within the licensed child care system has declined.

On January 11, 2022, Council received a report on the County's plans to utilize this funding, and approved plans to hire a temporary manager to support stabilization, quality, integration, and growth across the local system of Licensed Child Care and Early Learning.



Lake Simcoe Regional Airport Plan of Subdivision

Since acquiring ownership of the LSRA in January 2020, the County has initiated a number of projects to assist with the present and future development of the airport and increase the LSRA's economic

competitiveness. One of these initiatives is completing the process to have a registered plan of subdivision on the airport lands. This proposed plan refers to the process by which airport lands will be 'subdivided' into 19 separate commercial blocks of land, as opposed to 'subdivisions' in the residential context for housing purposes.

The airport lands are currently one large parcel, which poses challenges for tenants and the County. This change will allow tenants/developers to engage in land leases exceeding 21 years at the airport, which will assist them in securing financing. In addition, the LSRA has numerous leases on the subject property, which results in all of the tenants' municipal taxes appearing on the overall LSRA tax bill. This creates an administrative burden on the County, as airport staff are then required to categorize and determine the appropriate amount per tenant and then engage in billing and follow-up activities. The plan of subdivision will allow property taxes to be issued directly to the hangar owners and contractually controlled through Land Lease Agreements.

On January 11, 2022, Council approved the necessary by-law to authorize the removal of subdivision approval authority delegated under Section 51.2 (2) of the Planning Act to the Township of Oro-Medonte for this application.

Fire Services Review Follow-Up and Land Use Planning Service Delivery Review

County Council has passed a number of resolutions related to governance and the service delivery review. Among them was RGR-13-19, which reads: That the County engage a third-party consultant to conduct a comprehensive review of Fire Services in Simcoe County, identifying possible efficiencies and preferred Service Delivery models including regional and sub-regional service models. County Council also voted to engage third-party consultants to conduct a comprehensive review identifying efficiencies and potential streamlining of processes with respect to land use planning services and approvals performed by the County and its member municipal partners.

Through an RFP process, Pomax Consulting Inc. was selected to complete the review to identify efficiencies and to assist fire services and municipalities with providing value to the community. StrategyCorp was engaged to conduct a Land Use Planning Service Delivery Review with the goal of improving the County's planning a development approvals partnership with its 16 local municipal partners in land use planning.

On January 11, 2022, Council received the final reports from both Pomax and StrategyCorp. Council voted to forward Pomax's report to member municipal councils, with a request to review and consider the efficiencies, service delivery models and recommendations outlined in the review and advise the Regional Government Task Force on how the municipality would like to move forward in light of the review's findings. Council also moved that should the member municipalities see promise in some or all of the recommendations, the County can be identified to assist where appropriate.

On January 11, 2022, Council also endorsed the outlined opportunities in StrategyCorp's report and directed staff to implement identified opportunities and undertakings at the County and Local Municipal Level which can be done within current resources, and report back with an implementation strategy and proposed budget for all others, with updates being provided to County Council as required. Staff were also directed to continue to monitor the outcomes of the Provincial Conservation Authority Review and implementation of these recommendations, reporting back to County Council with outcomes and any further opportunities to create a consistent and efficient process.

Ontario-Municipal Summit Seeks Solutions to Build More Homes

Province announces more than \$45 million to help streamline development approvals and increase housing supply

January 19, 2022 Premier's Office

TORONTO — Today, Premier Doug Ford and Steve Clark, Minister of Municipal Affairs and Housing, met with big city mayors and regional chairs to discuss the housing crisis and coordinate efforts to increase the supply of homes across the province. The virtual summit provided provincialmunicipal leaders with an opportunity to share best practices, identify persistent issues and collaborate on ways to build the right mix of housing.

"Young families, seniors and all hardworking Ontarians are desperate for housing that meets their needs and budget," said Premier Doug Ford. "At a time when our province is growing, our government will continue to use every tool we have to help municipalities get more homes built faster to help more families realize the dream of home ownership."

During the summit, Premier Ford announced more than \$45 million for a new Streamline Development Approval Fund to help Ontario's 39 largest municipalities modernize, streamline and accelerate processes for managing and approving housing applications. For example, municipalities can use the funding to implement online systems that make it easier for applicants to navigate the development approvals process, manage their applications and receive timely status updates.

"After a decade of mismanagement and inaction under the previous government, the housing crisis in Ontario will not be solved overnight or in one meeting – addressing housing supply is a long-term strategy that requires long-term commitment, collaboration, and coordination," said Minister Clark. "Today's Summit was an important next step to identify what additional measures we can take to increase the supply of housing and make it easier for Ontarians and their families to find a home that meets their needs and budget. As we continue this dialogue, our government will ensure municipalities have the tools and resources they need to unlock housing in every community across Ontario."

The government also announced over \$8 million through the Audit and Accountability Fund to help large urban municipalities identify potential savings and efficiencies through third-party reviews to further accelerate the creation of new housing and modernize municipal services.

As an additional measure to help build more homes faster, the province also committed to work with the municipal sector to develop a data standard for planning and development applications to help accelerate approval timelines. Built with municipalities, data standardization will help improve the quality of data, create consistency across systems, make it easier to



measure results, reduce costs for business and governments, and support municipalities' transition to digital service delivery and digital approvals. This work is part of the <u>Ontario Data Authority</u> initiative, designed to accelerate Ontario's economic and social growth through improved data sharing.

The government's housing policies under <u>More Homes, More Choice:</u> <u>Ontario's Housing Supply Action Plan</u> are working to increase the supply of the full range of housing options, from single-family homes to midrise housing to purpose-build rental apartment buildings. In 2020, the year after More Homes, More Choice was implemented, Ontario saw the highest level of housing starts in a decade and the highest level of rental starts since 1992.

Everyone has a role to play in addressing Ontario's housing crisis. The government is working with municipalities to ensure they have the tools they need to unlock housing through this Summit as well as a Rural Housing Affordability Roundtable with rural, remote and northern municipalities on January 23. Additionally, the government is engaging with industry experts on the Task Force and recently held an <u>online public consultation</u> to inform the province's next steps on additional measures that will help more Ontarians find the home that is right for them.

Province collaborating with small and rural municipalities to build more homes faster

TORONTO — Today, Premier Doug Ford and Steve Clark, Minister of Municipal Affairs and Housing, hosted the Rural Housing Roundtable with Ontario's smaller and rural municipal mayors, reeves and wardens to discuss the housing crisis and coordinate efforts to increase housing supply across the province.

"Thank you to each and every municipality that participated in today's roundtable, as we work to identify and implement concrete solutions to allow more families to realize the dream of home ownership."

TORONTO — Ontario is investing \$750,000 to help communities across the province become more inclusive and accessible for people of all ages and abilities.

Applications for the next round of Inclusive Community Grants opened today. These grants provide successful municipalities, non-profit community organizations, and Indigenous communities with up to \$60,000 for a local project that will help older residents and people with disabilities participate in community life. This year, Ontario will prioritize projects that support under-served communities and those that address COVID-19-related challenges.

"Our communities are made stronger when we ensure everyone is included in community life," said Raymond Cho, Minister for Seniors and Accessibility. "That's why I'm proud to announce the launch of the latest round of funding for Inclusive Community Grants, which will help communities across the province design and implement community-based projects to meet the needs of seniors and people with disabilities."

The Inclusive Community Grants program was created in November 2020 and funding from the first round went towards projects such as:

- Making public buildings and outdoor spaces more accessible in 13 rural communities across the Haliburton and Kawartha Lakes region
- Developing culturally appropriate age-friendly community resources for Haudenosaunee Elders at Six Nations Health Services

Province capitalizes on its world-class clean electricity grid to give businesses new option to meet environmental and sustainability goals

January 26, 2022 Ministry of Energy

TORONTO – As environmental and sustainability goals increasingly influence corporate decisions on where to invest and grow, the Ontario government is taking action and leveraging the province's world-class clean electricity grid by developing a voluntary clean energy credit (CEC) registry to boost Ontario's international competitiveness and attract jobs.

"Ontario families have done the heavy-lifting and built one of the cleanest electricity grids in the world. Our government is ensuring Ontario is leveraging this competitive advantage to drive investment and create jobs." said Todd Smith, Minister of Energy. "The creation of a clean energy credit registry will give businesses the opportunity to meet their corporate environmental and sustainability goals when choosing to operate in Ontario and will also generate revenue which could be returned to Ontario ratepayers to help lower electricity costs."

Voluntary CECs are certificates that each represent 1 megawatt-hour (MWh) of clean electricity that has been generated from a non-emitting source, such as solar, wind, bioenergy, hydroelectric and nuclear power. A provincial CEC registry will leverage Ontario's already world-class clean electricity system, that was 94 per cent emissions-free in 2020, and allow businesses to voluntarily purchase and retire these CECs to meet their corporate sustainability goals and demonstrate that their electricity has been sourced from a non-emitting resource. A CEC registry could return funds raised through the purchase of CECs to Ontario ratepayers and could support future clean energy generation in the province.

The Ontario government has directed the Independent Electricity System Operator (IESO) to research and report back on the design of a provincial CEC registry, that would give businesses more choice in how they achieve their corporate sustainability goals. The IESO will deliver its report by July 4, 2022. The government will consider the report as well as stakeholder input, with the intention of having the registry available by January 2023.

"A voluntary clean energy credit market could be a key tool to help Ontario electricity customers realize their clean energy preferences," says Lesley Gallinger, President and CEO of the IESO. "We will engage with industry stakeholders, businesses, and others as we assess options for a potential market."

The commitment to develop a registry builds on continued government action to make Ontario the best place to create jobs by cutting red tape and electricity prices all while



helping businesses reduce emissions to meet the Made-in-Ontario Environment Plan's climate targets. This will make life easier for Ontarians by returning more money to their pockets as they continue to deal with financial challenges presented by the pandemic and will help protect the environment for future generations.

"By lowering taxes, reducing electricity costs and cutting red tape, our government has reduced the cost of doing business in Ontario by \$7 billion a year," said Vic Fedeli, Minister of Economic Development, Job Creation and Trade. "Developing a clean energy credit registry with flexible options adds to the list of benefits to businesses looking to expand and invest in Ontario."





Barrie Collingwood Railway Active Transportation Trail

The Study

The County of Simcoe has identified an opportunity to provide inter-community active transportation with the development of the Barrie Collingwood Railway (BCRY) Active Transportation Trail, between Stayer (Township of Clearview) and Angus (Township of Essa) for a distance of 23 km. The County is undertaking a Municipal Class Environmental Assessment (MCEA) to consider options for the development of the BCRY Trail. The site location and approximate extent of the Study Area are shown on the map.



The Process

The Study will follow Schedule B of the *Municipal Class Environmental Assessment* (Municipal Engineers Association, October 2000, as amended in 2007, 2011, & 2015), which is an approved process under the *Ontario Environmental Assessment Act*. The MCEA process includes: consultation with agencies, stakeholders, Indigenous communities and public; alternative design concepts for the preferred solution; an assessment of potential environmental impacts; and, identification of reasonable measures to mitigate any potential adverse impacts. At the conclusion of the Study, a Project File Report (PFR) will be prepared for public review.

Input Invited or Comments Invited

Consultation is important to this Study. The County of Simcoe would like to ensure that anyone interested has the opportunity to provide input into the planning and design of the project. As part of these ongoing efforts, we would like to share with you that today we are boosting the per claim administration payment amount provided to municipalities through the Ontario Wildlife Damage Compensation Program (OWDCP).

We understand the important role OWDCP plays in supporting farmers by providing compensation when their livestock and/or poultry has been injured or killed by wildlife, and to beekeepers whose beehives, bee colonies and related equipment are damaged by wildlife.

Municipalities are valued partners in delivering the OWDCP, and we appreciate your commitment to administering this program. In recognition of the crucial role municipalities play, the payment amount provided to municipalities will increase to \$50 per application, from the previous \$30, for any application with an injury/kill date of February 1, 2022 onwards. This increase recognizes that municipalities' incremental costs of program delivery have increased because of changes made over the past few years to strengthen the program.

To ensure a smooth transition date, February 1, 2022, municipalities will be able to begin accessing the increased payment amount through OWDCP. This coming into force date will also ensure a smooth transition, as well as minimize any potential errors in payments or financial reporting.

This timely investment will help to sustain one of the business risk management supports that our livestock farmers count on to do the invaluable work that they do in supplying safe, high-quality food for the people of the province.

Our government is committed to ensuring that conservation authorities are focused on helping protect people and property from natural hazards, the conservation and management of conservation authority-owned lands, and their roles in drinking water source protection.

To implement recent changes made to the *Conservation Authorities Act* (CAA), three new regulations were filed on October 1, 2021 as part of the first phase of regulations. These regulations set out details of the new framework for programs and services that support the core mandate of conservation authorities and consolidated the 'conservation area' regulations.

Building on that progress and to support a smooth transition by conservation authorities to the new funding framework by January 1, 2024, the second phase of regulatory and policy proposals have

been posted for consultation on the Environmental Registry of Ontario (<u>notice number 019-4610</u>). The government is making these proposals to improve overall governance, oversight, transparency, and accountability of conservation authority operations, and the proposals include municipal levy provisions, proposed budget process, and classes of programs and services for which conservation authorities can charge a fee.

The government is proposing regulations and a policy that would include:

- Details, through a Lieutenant Governor in Council regulation, governing the apportionment by conservation authorities of their capital costs and operating expenses to be paid by their participating municipalities through municipal levies, as well as related conservation authority budgetary matters, including requirements that conservation authorities distribute their draft and final budgets to relevant municipalities and make them publicly available i.e. 'Municipal Levies regulation';
- Details, through a Minister's regulation, governing the methods available for CAs to determine costs specified municipalities may need to contribute for the authority's mandatory programs and services under the *Clean Water Act, 2006*, and the *Lake Simcoe Protection Act, 2008* i.e. 'Determining Amounts Owed by Specified Municipalities regulation';
- Classes of programs and services, through a Minister's published list, in respect of which a conservation authority may charge a user fee – i.e. 'Fee Classes Policy', and
- Requirements to increase transparency of authority operations.

The Ministry of the Solicitor General is committed to keeping communities across Ontario safe, supported and protected.

In fall 2020, the ministry hired an independent consultant, Goss Gilroy Inc., to conduct a review of court security and prisoner transportation in Ontario, including the design of the Court Security and Prisoner Transportation (CSPT) Transfer Payment (TP) Program. Under the CSPT TP Program, the ministry provides funding to municipalities to assist them in offsetting costs associated with both court security and prisoner transportation.

The review is part of the ministry's ongoing work to leverage technology and improve public safety to build a more responsive and efficient justice system across the province. This includes initiatives such as the Criminal Justice Digital Design (CJDD) and the Criminal Justice Video Strategy (CJVS). CJDD is modernizing the criminal justice sector by digitizing criminal case records and connecting IT systems to ensure data flows seamlessly from police, prosecution, courts and corrections and is readily available to the right people at the right time for decision-making. In addition, CJVS is designed to increase the use of video technology for most types of in-custody court appearances. This reduces the need to transport accused between correctional institutions and courthouses and in turn, improves safety and overall system efficiencies.

Municipalities, police services and other justice sector partners were engaged during the review of court security and prisoner transportation. This review is now complete and in turn, the ministry would like to share the enclosed high-level summary and full report (enclosed). We appreciate the time and effort provided by individuals and organizations during the review process. As a result, valuable feedback on how we can strengthen best practices, as well as explore ways to improve the delivery of court security and prisoner transportation was obtained. The ministry is taking a phased approach in response to the program review to ensure a pathway for future planning and continuous improvement predicated on good evidence that addresses gaps in the program review. It is important to note that there will be no changes to the overall funding envelope of the CSPT TP Program, subject to the regular fiscal process.

Public safety is a top priority for our government and providing our frontline police and their municipal partners with the tools, resources and financial supports they need to protect our communities is critical to this endeavor.

We look forward to continuing to work closely with you and other municipal and justice sector partners on court security and prisoner transportation and on other shared public safety priorities.

A High-Level Summary of the Court Security and Prisoner Transportation Program Review

Engagement Approach

A range of consultation activities led by Goss Gilroy Inc., detailed below, took place between fall 2020 and spring 2021. Over 200 individuals participated.

What We Heard: A Snapshot

Funding Model

- Generally, participants are concerned about the fairness and effectiveness of the current funding model for court security and prisoner transportation. Those with courts located in their jurisdictions bear the full net cost of court security, including overtime outlays, as well, the retrospective nature of the grant does not reflect real-time expenditures.
- First Nations police services in Ontario expressed concern that they are not eligible for funding under the CSPT TP and therefore are assuming these expenses.

Prisoner Transportation

- The expanded use of virtual court appearances, accelerated by the pandemic, should be maintained where feasible, but infrastructure limitations and impacts on human resources must be addressed.
- Special Constables are appropriate resources for conducting prisoner transportation and court security, but not all police services leverage these positions.
- The OPP Offender Transportation Unit is generally seen as an effective model; however, there are exclusions that cause some jurisdictions to have to expend additional resources to meet all prisoner transportation needs.
- The interface with correctional institutions is key in terms of achieving efficient prisoner transportation. Scheduling and the coordination of prisoner pick-up and drop-off at some correctional institutions and courts could be improved—technology solutions should be explored.

Court Security

- While courthouse facility improvements have enhanced security in some locations, outstanding facility issues have not all been addressed in other locations.
- Some concerns about contracting for court security functions exist; however, some jurisdictions demonstrated success in contracting courthouse screening activities.
- Unique challenges for Northern Ontario and remote locations cause disruption to front-line policing services when officers are redeployed to court security or prisoner transportation activities due to geography and resource gaps.
- Conflicts were identified between courthouse stakeholders' requests for additional security and constrained police budgets that cannot accommodate increased expenditures.
