## TRAILS CONNECTING COMMUNITIES PROGRAM - 2023

Information Sheet and Application Guide

#### 1. Introduction

The County of Simcoe has dedicated funding for 2023 to assist local municipalities in the development of active transportation and recreational trail opportunities, with a focus on enhancing and/or expanding the trail network for non-motorized uses. The following information is intended to outline the basic information regarding the Trails Connecting Communities Program (TCCP).

## 2. Eligibility

The TCCP funding is available to local municipalities within the County of Simcoe. Trail projects may be initiated by community groups, trail associations, recreation associations, institutions, crown corporations and Conservation Authorities in partnership with the local municipality, however, both local municipalities and the TCCP applicant must be financially committed to the project. It should be noted that the TCCP is a <u>reimbursement</u> program. Applying municipalities should be prepared to incur all of the costs of the project and then request reimbursement from the County of Simcoe at project completion. As a minimum, projects are required to meet the following criteria:

- Project will enhance an existing trail or establish a key trail linkage to improve network connectivity.
- Project will be constructed to specifications that improve trail accessibility to people with disabilities.
- Projects will work towards linking local municipalities and/or settlement areas.
- Construction will begin in 2023 or 2024 and be completed by the end of 2024 (unless alternate scheduling is confirmed).
- Project/trail design is satisfactory to County staff (i.e. access, signage, width, surface material, etc.)
- All construction activities will occur in accordance with applicable policies, bylaws, standards and regulations.

Note: The Applicant is required to pre-consult with the TCCP Coordinator to discuss the proposed plans prior to submitting their application.

#### 3. Available Assistance

Projects will be funded up to 50% of the total eligible costs, to a maximum of \$30,000, with County funds matching the contributions of the local municipality or increased funding available through the County TCCP reserve funds with County Council approval. Exceptions to the maximum may be granted for projects involving partnerships between municipalities.



## 4. Expenditures

## a. Expenses eligible to receive matching funding include:

- Construction materials, bridges, signage, benches, access barriers, ramps, trailhead shelters/pavilions, surfacing material, contracted workers and equipment
- Trail property purchase
- Technical and/or Feasibility studies

## b. Ineligible expenses include:

- Wages for part-time and full-time municipal employees or trail group
- Municipal equipment costs
- Property taxes, insurance
- Legal and/or Administration Costs
- Food related expenditures food expenses for banquets, dinners, fundraisers and celebrations
- HST

## 5. Application Process & Requirements

The **primary intake** period for TCCP applications is from **April 24**, **2023 to May 26**, **2023**. Applications received during this period will be given first consideration depending on budget availability and compliance with the TCCP criteria. Applications received after the primary intake period may be considered for any remaining funds on a first come-first served basis. The following materials are to be submitted in support of a complete application:

Successful applicants will be notified, in writing, of the County of Simcoe's commitment to fund their respective project. Following receipt of the County's Letter of Commitment, applicants will be subject to periodic project progress updates over the course of the project.

## 6. Obligations

By receiving assistance funding from the County of Simcoe, applicants acknowledge that certain obligations must be adhered to. These include the following:

- All projects receiving TCCP funds will be completed by Friday, November 15, 2024.
- Upon completion of the project, the County of Simcoe requires the following materials to be submitted by the local municipality to the TCCP Coordinator by Friday, November 29, 2024 to confirm the eligibility of the project:

A signed letter confirming the works completed, the amount of money spent by the local
municipality on the project, and the amount of money requested through the TCCP program
Confirmation that the trail or trail infrastructure has been constructed to comply with Trail
Accessibility for Ontarians with Disabilities Act (AODA)
Post-construction photos of the project site (where applicable)

Please note that failure to provide the required information may result in a reduction or withdrawal of the County of Simcoe's funding commitment. Funds granted through the TCCP are not transferable. The County of Simcoe must approve, in writing, <u>prior</u> to any significant change in the use of committed funds. Unused funds, or funds that were spent incorrectly, must be returned to Simcoe County. Signage related to the trail project construction shall acknowledge the County of Simcoe as a partner in the project and shall be reviewed by the TCCP Coordinator, and all applicants will save harmless the County of Simcoe for any liabilities, problems or issues that arise either during or after the TCCP 2023 funding process.

#### 7. Trails Accessibility Standards

Further to the above Section 6, titled Obligations, municipalities are to follow the **Accessibility for Ontarians with Disabilities Act (AODA)** standard for the design of public spaces. This standard ensures that exterior paths of travel, recreational trails, beach access routes, outdoor play spaces and parking areas are made to be accessible to all people. Please consult your local Accessibility Committee or the Government of Ontario AODA for up-to-date requirements and guidance. Requirements for the design of recreational trails include:

- Clear Width: 3 metre minimum to allow two-way traffic (1.5 metres each direction)
- Clear Height: 2.1 metres headroom above trails
- Trail Signage: signage must be in accordance with Regional Tourism Organization 7 Standards
- Surface Material: trail surfaces must be firm, stable and accessible. Please note the following:
  - Concrete or asphalt: Accessible
  - o Crushed stone: Moderately accessible
  - o Grass/ gravel/ wood chips: Not accessible

# County Council endorses plan to create 176 new affordable rentals in the City of Barrie

Midhurst/April 26, 2023 – County Council voted yesterday to endorse the plan to create a 176-unit mixed-use building at the County's Rose Street location. With this \$186-million commitment, this building will be home to 176 deserving families, seniors, and individuals. It will house a variety of community services including an Ontario Works office, community programming, and other amenities (such as a possible daycare space, medical offices, and more).

"County Council once again demonstrated our commitment to building up our communities and investing in long-term, sustainable solutions," said Warden Basil Clarke. "Our Social and Community Services staff came to us with an incredible proposal that isn't just a building — it offers greater hope and stability for future residents. At \$186 million, this is a significant investment by the County. Council wants to ensure that we're making



the biggest impact possible as we forge ahead and use this build as a foundation for our next 10-year regional housing strategy."

This development will include diverse or mixed housing types, including rent-geared-to income, affordable housing, and units for the "missing middle", in addition to space for social, health and community partners. The 1.9-hectare (4.7 acre) site is in a central location in the built-up urban setting with access to commercial amenities, schools, transit and pedestrian connectivity. Community consultation will occur as the process continues.

The County incorporates well-designed housing that is built to last while providing safety, health and affordability to tenants. Affordable housing created through the Rose Street development will allow low to moderate income households, and will provide homes for single individuals, families and seniors in need.



With this approval by County Council to proceed, the

County expects that site preparation will begin in early 2024, with an estimated completion date in 2026-2027\* (\*subject to change). Recognizing the unique opportunity at the Rose Street site in Barrie, Council also asked staff to report back on further options to maximize the site for



additional units. Staff will report back to Council with options and recommendations in the coming months, as the approved projects begins.

Dear Lisa Lehr.

Thank you for your correspondence dated February 22, 2023, to the Hon. Stephen Lecce, Minister of Education, regarding a new elementary school in Angus, ON. Your letter has been forwarded to me and I am pleased to respond.

As you may know, the Capital Priorities Grant Program (Capital Priorities) provides funding for capital projects to address accommodation pressures; replace schools due to their condition; address the needs of under-served French-language rights holders; and build child care centres in schools.

Through the 2021-22 and 2022-23 round of Capital Priorities, Simcoe County District School Board (DSB) submitted a project proposal for a new 501 pupil place elementary school in Angus. The demand for school project funding in the province was significant and the ministry had to make difficult decisions. As a result of this and the limited funding available, only a portion of funding requests from across the province was approved.

While Simcoe County DSB's project in Angus was not approved, the school board can include this priority project as part of the school board's submission for the next round of Capital Priorities. At this time, the timeline for the next round of the program has not yet been identified. Once information regarding the next round is confirmed, the program launch will be communicated directly to the school boards.



In terms of increased class sizes at local elementary schools, the <u>Class Size Regulation</u> (O. Reg. 132/12) sets out class size requirements for all grades. While the Ministry of Education provides the framework, funding, and flexibility needed to support school boards in meeting class size requirements for all grades across the province, it is the responsibility of the school board to make the appropriate staffing decisions to meet these standards and to organize classes accordingly.

Thank you for your correspondence, which was sent to me by the Honourable Doug Ford, Premier of Ontario, containing the resolution passed by Council of the Township of Essa, relating to municipal costs and removal of revenue from Criminal Record Checks. As Solicitor General of Ontario, I am pleased to respond.

Please be assured that public safety is a top priority for our government. We are committed to working with our policing and community partners to provide them with the resources and tools they need to keep Ontario's communities safe and resilient.

The creation of the new centralized platform for Ontario Provincial Police (OPP) Online Police Record Checks has eliminated the requirement for OPP detachment staff to perform these checks. While the OPP has not changed the revenue that municipalities receive from police record checks at this time, this is currently being reviewed.

The Ministry of the Solicitor General has general authority over the delivery of police services in Ontario. Ministry staff members monitor the activities of all police services in Ontario and, where appropriate, recommend improvements to legislation and procedures. The Ministry of the Solicitor General does not have the authority to direct police in their day-to-day operations or budgets.

The ministry does, however, offer funding supports to policing and community partners through various grant programs that are primarily available to police services, working in collaboration with community partners, to address local community safety issues. For example, the Community Safety and Policing (CSP) Grant provides eligible police services and boards with greater flexibility to implement initiatives that address policing needs and priority risks related to safety and well-being. Under the current CSP Grant cycle, the Nottawasaga Police Services Board has been allocated \$294,000 over three fiscal years (2022-2025) to support the *Nottawasaga Continue Safe Pathways project*, which aims to proactively address local crime and complex social issues including sexual violence, harassment, human trafficking, mental health and addictions.

In addition, through the Victim Support Grant (VSG) program, the Ontario government is investing approximately \$5.9 million over two years (2021-23). The VSG program aims to help improve access to critical supports for victims and survivors of intimate partner violence and human trafficking, including culturally appropriate supports for racialized victims/survivors. This grant focuses on providing funding to police services to develop new or enhanced victim/survivor supports in collaboration with local community organizations, agencies, or indigenous communities. Specifically, OPP Nottawasaga was allocated \$168,000 over two years for their initiative *Project Safe Paths,* which aims to enhance OPP Nottawasaga and surrounding OPP Detachments with their current abilities to deal with and support victims of human trafficking and partner violence and more.

## Bill 175, Safer Ontario Act (2018)

The Government of Ontario has demonstrated its commitment to supporting communities by developing a provincial approach to community safety and well-being.

Under the Province of Ontario's Bill 175, Safer Ontario Act (2018), the Ministry of the Solicitor General requires that the Council of every municipality shall prepare and, by resolution, adopt a Community Safety and Well-Being (CSWB) Plan on or before July 1, 2021

## Why it Makes Sense

Social disorders become justice issues for no good reason. That is, Police often find themselves responding to calls that do not result in chargeable offences. The calls are re-routed to more appropriate service providers.

CSWB strategies should focus on inter-sectoral collaboration and information sharing to identify more proactive approaches to mitigate many of these crisis scenarios

## How We Measure

When we review the CSWB model, we often see a focused effort on incident response and risk intervention. The goal of the Plan is to move towards prevention and social development approaches. These system-level changes are often difficult to measure for a few reasons that include, but are not limited to:

- Longer runway needed (time) before change (impact) can be measured
- Collaborative nature of the work (many sectors/ministries/organizations/funders) means there is not one (single) metric to follow

Title: Road Management Action on Invasive Phragmites

Date: Friday, April 21, 2023

Moved by: Councillor Barton

WHEREAS *Phragmites* australis (*Phragmites*) is an invasive perennial grass that continues to cause severe damage to wetlands and beaches in areas around the Great Lakes including Georgian Bay; and

WHEREAS *Phragmites* australis grows and spreads rapidly, allowing the plant to invade new areas and grow into large monoculture stands in a short amount of time, and is an allelopathic plant that secretes toxins from its roots into the soil which impede the growth of neighboring plant species; and

WHEREAS *Phragmites* australis results in loss of biodiversity and species richness, loss of habitat, changes in hydrology due to its high metabolic rate, changes in nutrient cycling as it is slow to decompose, an increased fire hazard due to the combustibility of its dead stalks, and can have an adverse impact on agriculture, particularly in drainage ditches; and

**WHEREAS** invasive *Phragmites* has been identified as Canada's worst invasive plant species by Agriculture and Agrifood Canada; and

WHEREAS the Ontario government has made it illegal to import, deposit, release, breed/grow, buy, sell, lease or trade invasive *Phragmites* under the Invasive Species Act; and

WHEREAS *Phragmites* occupy over 4,800 hectares of land around Lake St. Clair alone, while 212 hectares of *Phragmites* occupy land along the St. Lawrence River. The Georgian Bay Area is particularly affected by *Phragmites* australis, with more than 700 stands along the shorelines and multiple visible stands on the highways and roads that threaten valuable infrastructure and wetland areas; and



WHEREAS volunteers, non-governmental organizations, and various municipalities have invested tens of thousands of dollars in investments and labour annually for more than eight years in executing managements plans to control invasive *Phragmites* on roads, coasts, shorelines and in wetlands; and

WHEREAS roads and highways where *Phragmites* that are left untreated become spread vectors that continually risk new and treated wetlands and coastal shoreline areas; and

WHEREAS according to "Smart Practices for the Control of Invasive *Phragmites* along Ontario's Roads" by the Ontario *Phragmites* Working Group, best road management practices for *Phragmites* australis include early detection, herbicide application, and cutting; and

WHEREAS these best management practices are most effective when used in a multi-pronged approach as opposed to when used as stand-alone control measures; and

**WHEREAS** Mother Nature does not recognize political boundaries. Therefore, it is imperative that Municipalities, Districts, the Province, and the Federal government work together in collaboration to eradicate Canada's worst invasive plant species *Phragmites* australis.

**NOW THEREFORE, BE IT RESOLVED** that Council for the Township of The Archipelago directs its staff to implement best management practices to promote early detection of invasive *Phragmites*, and to implement best management practices for invasive *Phragmites*, and to join the Ontario *Phragmites* Working Group to collaborate on the eradication of *Phragmites* in Ontario.

**BE IT FURTHER RESOLVED** that Council for the Township of The Archipelago directs staff to insert clean equipment protocols into tenders and that there is oversight that the protocols are followed.

**BE IT FURTHER RESOLVED** that Council for the Township of The Archipelago requests the Ontario Ministry of Transportation to map and treat invasive *Phragmites* annually on all its highways.

**BE IT FURTHER RESOLVED** that the Ontario Ministry of Transportation (MTO) communicates the strategy on mapping (detecting sites) and controlling invasive *Phragmites* on provincial highways, the specific highway management plans and results by each MTO region and each highway in the region and work in coordination with Township of The Archipelago.

**BE IT FURTHER RESOLVED** that Council for the Township of The Archipelago directs its staff to send this resolution to all municipalities that are part of the Georgian Bay watershed, to the Minister of Transportation, Christopher Balasa the Manager, Maintenance Management, and MPP (the Municipality's local MPP).

**BE IT FINALLY RESOLVED** that Council for the Township of The Archipelago requests all levels of government to consider funding support to aid the Township of The Archipelago in managing invasive *Phragmites*; and directs staff to send a copy of this resolution to the Ontario Minister of Environment, Conservation and Parks and the Minister of Environment and Climate Change Canada.

Thank you for your inquiry regarding the Accelerated High Speed Internet Program (AHSIP) in the Township of Essa.

The Ministry of Infrastructure is unable to share the list of addresses removed from the AHSIP program. The ministry intends to release more information about provincial broadband projects soon.

While your municipality is no longer part of the AHSIP, rest assured that the government has made it clear that enabling access to high-speed internet is a priority.

This includes a provincial investment of more than \$63 million towards the Southwestern Integrated Fibre Technology (SWIFT) project, which will help enable access for approximately 63,000 households and businesses, including in the Township of Essa, by June 2023.

In addition, in July 2021, the Ontario government announced its partnership with the Government of Canada to co-fund 58 high-speed internet projects across Ontario, including two projects in and around the Township of Essa. The Ministry of Infrastructure is working with the Government of Canada to move these projects forward as quickly as possible. More information will be shared when project agreements are finalized.

Please be advised that the Council of the Regional Municipality of Waterloo at their regular meeting held on April 19, 2023, approved the following motion:

WHEREAS the Municipal Elections Act requires all individuals wishing to be a candidate in a municipal or school board election to file Nomination Paper - Form 1 with the municipal clerk;

AND WHEREAS the Municipal Elections Act requires all candidates who sought election to a municipal council or school board to file Financial Statement – Auditor's Report Candidate – Form 4 with the municipal clerk;

AND WHEREAS Form 1 requires candidates to provide their qualifying address;

AND WHEREAS Form 4 requires candidates to list the name and home address of any donor contributing over \$100.00

AND WHEREAS the Municipal Elections Act specifies that these documents are not protected by the Municipal Freedom of Information and Protection of Privacy Act, and requires the municipal clerk to make Form 4 available on a website;

AND WHEREAS there has been concern expressed about those who hold public office and those who support them that they have been the subject of unnecessary attention and excessive scrutiny;

AND WHEREAS the requirement to publish the personal home address of donors to specific candidates may discourage individuals from

engaging in the democratic process to elect municipal and school board politicians.

THEREFORE, BE RESOVLED THAT the Regional Municipality of Waterloo calls on the Minister of Municipal Affairs and Housing for the Province of Ontario to protect the privacy of candidates and donors by removing the requirement for their street name, number and postal code to be listed on publicly available forms.

AND FURTHER THAT for verification purposes, the addresses of all candidates and all donors over \$100 be submitted to the municipal clerk on separate forms that are protected by the Municipal Freedom of Information and Protection of Privacy Act and will not be published.

AND FINALLY, that this resolution be forwarded to the Area Members of Provincial Parliament, the Association of Municipalities of Ontario, the Association of Municipal Clerks and Treasurers of Ontario, the Ontario Public School Boards' Association, the Ontario Catholic School Trustees' Association, and all Ontario municipalities.

#### What Is An EDC?



An Education Development Charge is a development charge that is imposed under a bylaw respecting growth-related net education land costs incurred or proposed to be incurred by a School Board.

In layman's terms this means it is a charge that is levied on new development (residential or non-residential) that is paid when the building permit is issued by the municipality. The revenue collected from the charge is used by a school board to purchase land/sites for new schools and to prepare those sites for construction of new schools.

Education development charges are the primary source of funding site acquisition needs for a school board (that qualifies) experiencing growth in its jurisdiction.

## **EDC Legislative Changes: A Summary**



On October 12, 2018, the Provincial government made a change to the legislation that pertains to education development charges;

- Ontario Regulation 438/18 amended Ontario Regulation 20/98 and namely;
  - **❖** Maintained EDC rates at the levels in existing EDC by-laws as of August 31, 2018



On March 29, 2019 the Ontario Government further amended the EDC legislation.

- Ontario Regulation 55/19 amended Ontario Regulation 20/98.
- ❖ O. Reg 55/19, essentially lifted the EDC rate freeze by implementing a provisional phase-in of proposed EDC rates.

- In year 1, the existing EDC rate could be increased by \$300 or 5% of the existing residential EDC rate, whichever is greater. The non-residential rate can similarly be increased by \$0.10 or 5% of the existing nonresidential EDC rate;
- In the second year of the by-law and in each subsequent year, the rate could be increased by another \$300 or 5% of the previous year's residential EDC rate, whichever is greater. Again, the non-residential rate can also be increased by another \$0.10 or 5% of the previous year's nonresidential EDC rate.
- Both the residential and non-residential rates are subject to <u>maximum</u> rates, which are the <u>proposed EDC rates in the EDC Background Study</u>.

## What Are The Existing Charges & How Are They Applied?



The Simcoe County District School Board (SCDSB) and the Simcoe Muskoka Catholic District School Board (SMCDSB) have existing EDC by-laws that cover the County of Simcoe.







## Comparison Of Appraised Values, 2013 to 2018



## Market Conditions In 2023: Challenges



- Limited market activity (sales reported) during the period of Covid influence building lots and serviced development sites with comparable density potential for a typical school site
- Rapid escalation of residential and employment real estate has occurred in recent years
- Residential development sites display increased densities which influences the underlying assumptions for school sites. Greater density, when met with demand, generally relates to higher land values.
- A recent softening in residential house pricing has not to date provided lands sales that show a similar reduction in value. There are a wide range of variables in play relating to land value which vary between the study area markets.

#### **How Can We Deal With The Challenges?**

Can stakeholder's help with critical baseline information including; building lot values, cost of typical developments, expectations for density, expectations for values? How can we better reflect market expectations from the stakeholder's perspective?

## Additional Education Act/Regulation Changes



Further legislative changes to the Education Act and the regulations governing EDCs were made in the Fall of 2019. A brief summary is provided below:

- Additional legislated EDC exemptions;
  - (i) private school;
  - (ii) long-term care home, as defined in the Long-Term Care Homes Act, 2007;
  - (iii) retirement home, as defined in the Retirement Homes Act, 2010;
  - (iv) hospice or other facility that provides palliative care services;
  - (v) child care centre, as defined in the Child Care and Early Years Act, 2014;
  - (vi) memorial home, clubhouse or athletic grounds owned by the Royal Canadian Legion;
  - (vii) college of applied arts and technology established under the *Ontario Colleges* of *Applied Arts and Technology Act, 2002*;
  - (viii) university that receives regular and ongoing operating funds from the Government of Ontario for the purposes of post-secondary education;
  - (ix) Indigenous Institute prescribed for the purposes of section 6 of the *Indigenous Institutes Act, 2017.*
- Alternative projects/local education developer agreements (LEDA)

## Alternative Projects & LEDA (Localized Education Developers Agreements)



Part of the legislative changes, introduced the possibility of new options for both school boards and building permit takers or developers.

#### ALTERNATIVE PROJECTS

A Board may request approval from the Minister of Education, that EDC monies be used towards an "alternative project". An alternative project is deemed as a "project, lease or other prescribed measure...that would address the needs of the board for pupil accommodation and would reduce the cost of acquiring land." Some examples provided by the Ministry of Education include, alternative parking arrangements (i.e. underground parking), additional costs attributed to vertical construction etc.


#### LEDA

A LEDA is an agreement between a school board and a landowner, such as a developer, in which the owner provides a means for pupil accommodation or other benefit to be used for pupil accommodation and in exchange, the geographical area that the LEDA will service will be exempt from the collection of EDCs. Examples of a LEDA provided by the Ministry of Education include, the provision of access to land (either through long-term lease or gift), owner constructs and provides facilities (podium schools) etc.
