a) Motion – Red-Light Camera Endorsement

Moved by Councillor Kiezebrink, Seconded by Councillor Maltby

WHEREAS traffic safety remains a significant concern for residents of the Township of Essa; and

WHEREAS Essa residents regularly witness drivers running red lights and stop signs, creating dangerous situations on local roads; and

WHEREAS there is significant risk for injury resulting from collisions where motorists run red lights; and

WHEREAS advancements in technology have made traffic safety devices, including red-light cameras, much more affordable and accessible to municipalities of various sizes; and

WHEREAS Red Light Camera technology has proven to be effective at reducing collisions and enhancing road safety at intersections;

NOW THEREFORE BE IT RESOLVED THAT Council of the Township of Essa hereby endorses a Red-Light Camera Program in the Township of Essa, and further,

- Council directs staff to investigate options for implementing a Red-Light Camera Program within the Township of Essa;
- Directs staff to prepare a Staff Report for consideration, to be presented to Council of which shall include:

- a. An analysis of potential locations for red light camera installations in the Township of Essa, based on collision data and traffic patterns;
- b. Estimated costs for implementation and ongoing operation of the Program;
- c. Projected revenue from fines;
- d. Potential impact on traffic safety and collision rates in the Township of Essa:
- e. Implementation timelines and resource requirements.
- 3. That Staff be directed to consult with other municipalities that have implemented Red Light Camera Programs to gather best practices and lessons learned.
- That Staff explore potential agreements and memorandums of understanding to facilitate an implementation of a Red-Light Camera Program in the Township of Essa. Motion Carried.
- b) Proclamation October 15, 2025 Learning Disabilities Awareness Day

WHEREAS, each October, we recognize Learning Disabilities Awareness Month. A time to raise understanding, reduce stigma, and support the millions of children, youth, and adults who learn in different ways; and

WHEREAS, Learning disabilities affect one in ten Canadians of all ages, and while lifelong disabilities, they are not an indicator of intelligence, effort, or potential; and

WHEREAS, Learning disabilities are neurological differences in how the brain receives, stores, processes, and communicates information, affecting important skills such as reading, writing, math, organization, and attention; and

WHEREAS, Individuals with Learning Disabilities are at significantly higher risk of mental health challenges, including anxiety, depression, and suicidal thoughts, often due to social isolation, feelings of inadequacy, and academic struggles. and

WHEREAS, October has been recognized as Learning Disabilities Awareness Month, a time to build understanding, break down stigma, and celebrate the strengths and talents of individuals with learning disabilities; and

WHEREAS, October 15 has been designated as Learning Disabilities Awareness Day, providing an opportunity to shine a light and focus attention on the unique challenges and achievements of individuals with learning disabilities; and

NOW THEREFORE, Council of the Township of Essa, do hereby recognize the month of October as Learning Disabilities Awareness Month, and further proclaim October 15, 2025, as Learning Disabilities Awareness Day in the Township of Essa. I encourage all citizens to recognize the importance of learning disabilities awareness, to support equitable opportunities, and to celebrate the contributions of individuals with learning disabilities to our community.
